RESOLUTION NO. 23-06 A PORT OF GRANDVIEW RESOLUTION LEVYING THE 2024 AD VALORUM PROPERTY TAXES AND EXCESS LEVY TAXES

WHEREAS, the Commissioners of the Port of Grandview have met and considered the budget for the calendar year 2024; and

WHEREAS, the Commissioners, in the course of considering the budget for 2024, have reviewed all sources of revenue and examined all anticipated expenses and obligations; and

WHEREAS, the Commissioners have determined that it is in the best interest of and necessary to meet the expenses and obligations of the Port of Grandview and a substantial need exists for the property tax revenue to be increased in 2024;

NOW THEREFORE, BE IT RESOLVED, the regular levy request in the amount of \$374,736.74, which is a \$3,638.35 dollar increase from 2023 levy amount and a 101% increase of that same 2023 levy amount, plus any amount allowed for new construction, plus any amount calculated in accordance with RCW 84.69.180 for the period of 10/1/2022 to 9/30/2023, including interest paid and increase in state assessed values.

A RESOLUTION OF THE PORT OF GRANDVIEW TO INCREASE THE 2024 PROPERTY TAX LEVY FOR THE PORT of GRANDVIEW ABOVE THE "LIMIT FACTOR" UP TO 101 PERCENT

WHEREAS, the Commissioners of the Port of Grandview have met and considered the budget for the calendar year 2024; and

WHEREAS, the Commissioners, in the course of considering the budget for 2024, have reviewed all sources of revenue and examined all anticipated expenses and obligations; and

WHEREAS, the Commissioners have determined that due to continued industrial development of new properties purchased, the Commissioners find there is a substantial need to increase the regular property tax levy rate above the rate of inflation;

NOW THEREFORE, BE IT RESOLVED, the limit factor for the regular levy for the calendar year of 2024 shall be 101 % of the highest amount of regular property taxes that could have been lawfully levied in this taxing district in any year.

NOW THEREFORE, the Commission of the Port of Grandview does ordain as follows:

The budget for the Port of Grandview, Washington for the year 2024 is hereby adopted at the fund level in its final form and content as set forth in the comprehensive budget document attached hereto.
