AMENDMENT TO GROUND LEASE

Port of Grandview- Addison Kay Sybouts

THIS IS AN AMENDMENT to the Ground Lease entered into between the PORT OF GRANDVIEW, a municipal corporation of the State of Washington, referred to as "Port" and ADDISON KAY SYBOUTS doing business as "Peace Love and Coffee", referred to as "Tenant", dated October 1, 2015. The Ground Lease and the Amendment to Ground Lease shall hereafter be referred to jointly as "Lease".

THE PARTIES HEREBY AGREE the Ground Lease shall be amended as follows:

A. Section 3 of the Ground Lease shall be amended to read as follows:

3. RENT. The Lessee shall pay rent for the demised premises in the amount of \$440.00 each month, plus the applicable leasehold tax of \$56.50, for a total monthly payment of \$496.50, effective January 1st, 2025. Payments will be allowed quarterly.

B. Section 8 of the Ground Lease shall be amended to read as follows:

- **8.** MAINTENANCE OF PROPERTY. Throughout the term of this Lease, Tenant, at its sole cost and expense, shall maintain the Property and all improvements then existing thereon in good condition and repair, subject to reasonable wear and tear, and in accordance with all applicable covenants, laws, rules, ordinances, and regulations of governmental agencies. All litter, trash, garbage or debris shall be collected and disposed of in approved containers.
- C. Except as specifically amended by this Amendment to Ground Lease, all of the terms and conditions of the Ground Lease shall remain in full force and effect.

THE PARTIES have entered into this Amendment to Ground Lease on the 1st day of January, 2025.
